Panhandle Back Country Horsemen April 19, 2008 Meeting Minutes

The meeting was called to order by President April Linscott at 7:36 PM.

Secretary Debbie Samovar read the March minutes which were approved as read.

Treasure Sharon Bruce reported we received the \$500 from the Litehouse Grant, giving us a balance of \$3,556.64 in checking, \$2,275.62 in savings, \$6,446.86 in a CD and \$14,506.24 in another CD, for a total cash asset of \$26,785.36.

Bills to be paid were: Debbie Samovar - \$196.10 for BCHI Photo Contest Banners, and \$12.69 for refreshments for the meeting; Sharon Bruce - \$35.82 for Bucket Raffle; Perry Saathoff - \$31.40 for the Tune-Up Clinic. We also received a bill from the Gazette Record for \$23.85 for the March newsletter and a letter from the Annual North Idaho Fair and Rodeo Open Horse Show for \$100 for a full page ad. Sherri Lionberger made a motion to pay the bills, seconded by Gene Bruce, motion passed.

OLD BUSINESS

CONVENTION / OUTDOOR SHOW - Gene Bruce reported the state board meeting which took place on Friday. There was a report given by Sherri Lionberger on the Forest Service Comment Period and how they need to hear from us. On the annual elections Rod Parks took over as the National Director, with Terry Steiner as alternate. They got bids on repairing the state website and went with McCall, it will cost about \$750 to get it up and running again, and \$20-\$30/mon to maintain and hope to have that up and running the beginning of May. Additionally, McCall is donating \$250 of the startup fee back to BCHI. Changes to the By-Laws went through. Phil Rvan of the Ways & Means went over the calendar proposal. There will be 11 monthly drawings of \$500 and a grand prize of a 3 horse slant trailer, which was donated at cost by Throu-bilt, the proposal passed. Phil Ryan represented BCH at the Sportsman Caucus which included 39 other sports groups. Marilyn Rousher reported on Broomtails, she wants your pictures and articles. Volunteer hours for providing labor, equipment, travel time and stock use was valued at \$411,318. Jack Lamb reported on the Foundation and that he was stepping down as president and Mitch Christenson from Twin Rivers was taking over. The Foundation is an avenue for corporations to make donations for tax

Bernie Lionberger reported on the convention that took place on Saturday. BCHI presented a plaque to Connie Glass for all her work on the website. Peter Stegner from Senator Crapo's office spoke regarding the "Preserving Our Equine Heritage" bill, which is in committee right now. Senator Cantwell is for it, but wont sign due to issues she has with the National Parks. Senator Tester of Montana is really for it and wants to get it through. It's moving slowing, wont cost much, but there are a lot of people who don't want us to use horses on public land. Steve Didier reported there is a bill to repeal of the Recreational User Fees. It's charged at trail heads and the money collected is to go back to the ground. In the eastern states, most of the money goes into administration and in some cases, only horse users are charged the fee. So many senators and the BCHA are working to get this fee repealed. The Forest Service is working on reclassifications of the trial system from 3 classes to 5, where some of those trails would not be required to be maintained for horse use. Tracy Gravelle, who works here in Avery, doesn't think that it will have much impact on the trails around here. Then there was a presentation on "The Scariest Thing

You'll Run Into On A Trail!" It was a mountain biker in full body armor and mirrored helmet came cycling into the building. Scott Jackson, a bike dealer in Lewiston wanted to talk to use about what bikers need to know and do when coming in contact with horses and what horsemen need to know and do when coming in contact with bikers. There was a great dialogue, from which a poster was created to be posted in bike shops. Phil Ryan reported that the Life Flight program had great response. Some chapters bought blocks of 100 memberships and making them part of their membership fees, others, just for those who wanted it. The membership picks up the balance between the bill and what your insurance pays, and if you have no insurance, they absorb the cost. Already had a member use it, Val Johnson had a heart attack at the convention in Lewiston and was Life Flighted out to Spokane. There was a vote on the calendar, it passed. There was a vote on the convention versus the outdoor show. There will be a board meeting at the outdoor show in April and the convention will travel around and will start this November (the second weekend) and will be in Salmon as this year is their 30th anniversary. Photo contest was the best turnout Bernie had ever seen.

REMOUNT RIDE – Teri Horton report that they are going over on Thursday night. 20 people have signed up thus far. You do need a permit, its \$8 for 3 days. There are corrals, water, easy riding with great trails to ride.

TUNE-UP CLINIC - Perry Saathoff reported that it was very cold. Services were provided by McKinlay & Peters and was held at The Ranch at Mica Meadows. There were 43 horses, with the first one being seen at 8:00 and the last one out at 10:30. Things went very smoothly.

FUND RAISER TRAIL CHALLENGE – Alan Harper report that the committee has a letter for people to take to companies for sponsorships (see page 9 for copy), we're looking to get \$100 or prizes. We need to think out of the box; hit up car dealerships and other business, beside the usual tack stores. It will be held at Rider Ranch. The site is a great location and the tentative dates are September 6th, 20th or 27, which needs to be pinned down. The ranch will do a BBQ, keeping the monies they make to cover expenses. There will be a 4-H classification, Jr. Division and adult division. Flyers will be posted at High Schools and Barns. Sherri Lionberger needs the exact date for the insurance company. The committee will ride the area to layout obstacles. This event will be in lieu of the Poker Ride.

WEB SITE – We still do not have a web site. Debbie Samovar suggested that we at least get a URL up with an "Under Construction" sign and if possible post the links to the newsletters. Gene Bruce said we should try to piggy back with the guy who is doing the states site. Joni Lueck with Selkirk Aviation has a great local web master and will see her on Tuesday and will talk to her and will follow up with the board on what she finds out.

ST JOE TRAVEL PLAN – Bernie Lionberger reported that the Spokane Mountaineers put the trails on a sheet of acetate and laid it over the St Joe map at the April 26th meeting. Mallard Larkins will be non-motorized. Fly Creek, Mosquito Creek, and Trail 50 were written up with the justification as to why they should be non-motorized. The FS wants to make a decision by August. Then after that it goes into the NEPA phase.






The Back Country Horsemen is a national organization dedicated to three main objectives:

This fund raiser will help us continue on with this mission.


