TUNE-UP CLINIC Saturday, April 11th

The Vet will start at 8:00 a.m. When you arrive, make sure you sign up with me; horses will be seen in the order that you have signed up. All horses must be checked in by 10:30 a.m.

DIRECTIONS: from CDA go east on I-90 to St Regis, take the St Regis exit and proceed N on hwy 135 approx. 18 mi to the junction of Hwys 135 & 200, turn east (right) onto hwy 200 approx. 9 mi to Perma (its basically a sign along the road), just east of Perma take the bridge across the Flathead River (road 382), immediately across the bridge turn right onto the gravel road, go about 3 mi to the remount station. It has corrals & several abandoned buildings; you can't miss it. There is plenty of parking, usable corrals, water and most likely grass but you may want to bring hay. The country is open with lots of cross country riding.

This is Salish-Kootenai Tribal land and each person is required to have a permit. Permits are issued by the Montana Fish, Wildlife and Parks Dept and can be secured in one of two ways. You can purchase it in person at the store in Plains or on line on the MT FW&P web site. A 3 day permit costs \$8 plus a handling fee (\$1.43 on line). To go to Plains at the store/gas station turn west at the junction of 135 & 200 and go approx 10 mi. To purchase online go to <https://app.mt.gov/Als/Index> 1. Input individual info 2. Input birth date and ALS # if you have one, if not hit submit, then click I am certain that I do not have an ALS number. 3. Then, go to the CSKT tribal permit section (towards the bottom), select Out-Of-State 3-Day Conservation Permit 4. Select date and proceed to checkout. **5. Print this out and keep with you on site.**

Please RSVP the Shriners 208-667-2949 or the Hortons 208-664-9775 so we can plan adequately. We will be going up Thurs, but folks are welcome to come when they can. We will do breakfast Fri, Sat and Sun and do the usual potluck and your own steak on Fri, and Sat night. Plan to feed yourselves Thurs eve and your lunches Fri, Sat and Sun. We'll leave on Sunday the 3rd whenever.

Panhandle Back Country Horsemen March 21, 2009 Meeting

Perry Saathoff opened the meeting at 0830. We had two guests present who were giving a presentation – Randy and Dave from Spokane, Washington. They have a number of stock products for sale, including a horse/mule back padding system to solve your saddle fit problems. Their company is Four Quarter Circle and they gave a demonstration of their product and left us a DVD as well to see their other products.

The Secretary read the minutes from February meeting and they were approved as read. Sharon gave the treasurer's report. Bills submitted were \$12.47 to Linda Wuest for a door prize, \$33.60 for postage and \$30.95 for the bucket raffle item to Sharon, \$8.00 to Sherri for snacks. Bob moved to pay the bills seconded by Jerry Shriner – passed.

Old Business:

The Escure Ranch ride was canceled due to weather – we will try to reschedule it for April 4. A message will need to go out through Debbie's email list.

The outdoor show in Lewiston and state board meeting is next weekend. We need to get as many people there to support it as possible. There are lots of activities both days to watch or get involved in. Bernie has a judge for the photo contest from the Lewiston Tribune.

There was some information that went out on the website that said we would combine CPR, trailer inspection and saw training in one day's event. This is not quite accurate, but Perry is pursuing the trailer inspection and saw training. He has not had much request for CPR training. Byron checked with George Miller and he is willing to put on the saw training again. Perry explained to new members why we need the training when we work for the Forest Service.

Perry explained more about the Bernard Peak Trail and that we did send a letter requesting to keep the trail open through the development that is proposed. Karen Kimball will stay up on the information and let us know. The hearing is April 6th.

Bea Christoffersen noted that she is with the Nordic ski club and they are also trying to promote 4th of July ski trails as more than just winter non-motorized trails and are planning to clear the trail in May. Their president has Perry's number and will call him regarding help on this.

Calendars – we have 10 left and would like to get them sold – they will be drawing again soon.

The Albany, Oregon wild mustang event that Lea Williams attended went well – the top horse went for \$5000, but some of the bottom ones went for adoption prices as they were not worked with.

Al Linscott said his ranch ride would be on October 3 – this is a great steak ride.

Tune up Clinic: Saturday April 11 at Mica Meadows. Coggins and Health is \$48, and they have 4-way, 3-way with West Nile, Strangles and can also float teeth if necessary that afternoon. Perry sent a sign-up around so the vets can bring the right amount of vaccines. It will start at 0800 and will be done in the order of arrival and sign up. They will have burritos, coffee and juice as well (for a small fee).

The Shriners and Hortons are trail bossing a Remount ride on April 30 – May 2, at the Remount Station near Perma, Montana. There is a great camping, parking, corrals available as well as great riding. This is an early ride with open country. They will send out more info in the April newsletter. Permits are needed, but you can do it online. This is on tribal land and they will check on you, so a permit is necessary. This info will also come out on the website, or you can buy the permits at Paradise.

Saturday April 25 is the Marie Creek trail clearing with the Bruce's trail bossing. We are still looking for a trail boss for the actual Marie Creek trail ride on May 9. Our meeting is on May 16, and there is a trail clearing scheduled at Heyburn State Park that same day with Perry as trail boss. The new visitor center is finished, but not open and we will be able to park in the parking lot there. Heyburn is a nice place to ride and our chapter has put in a lot of hours of work out there – they were happy to hear we wanted to come back out and clear trails.

Memorial Weekend will have a work project and fun outing at Craig Mountain at Maddan Corrals with Lionbergers as trail boss. They will find out more on the proposed activity at the outdoor show this weekend.

We still need trail bosses for several outings, including the Wahoo trailhead work. The Forest Service will provide the materials for the hitch-rails for there and for Spruce Tree.

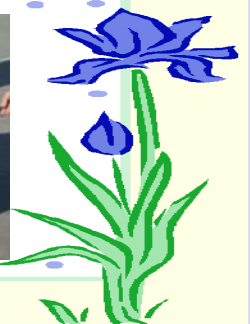
Bob Williams and Jerry Shriner won the door prizes of wormer.
