**PANHANDLE BACK COUNTRY HORSEMEN GENERAL MEETING – APRIL 18, 2009 MINUTES**

18 members present and no guests. Sharon Bruce read the minutes of prior meeting in Sherri Lionberger's absence. Minutes were accepted as read. Sharon gave the treasurer's report. Sharon advised that we received two checks from Back Country Horsemen of Idaho. One is for the 10% from sales of the BCHI calendar of \$400.00. The other check of \$125.00 was for placing 2<sup>nd</sup> place at the Outdoor Show on our chapter display. Bills presented were \$14.83 to Linda Wuest for the door prize, \$2.87 postage and \$89.04 for new stationary and membership cards (for five years) to Sharon Bruce and \$8.19 for website domain name transfer to Debbie Samovar. Marian Crumb moved to pay the bills and second by Gene Bruce. Motion carried.

Perry explained why we needed new stationary due to the fact our post office box, which is located in the U Do It Center on 4<sup>th</sup> Street is changing to Ace Hardware. Ace Hardware doesn't want the post office boxes; therefore they are closing it down effective April 30<sup>th</sup>. Sharon went ahead and got our new post office box at the Hayden branch and our new address is PO Box 1903, Hayden, ID 83835.

**Old Business:**

The Tune Up Clinic was a success, which was held at Mica Stables on April 11<sup>th</sup>. Perry said there were 28 horses taken care of. This year Krista Porter, the vet at McKinley & Peters, brought the stocks. This was great, because it was used to float teeth and to give shots for some of the stock. All of the animals were taken care of and done by noon. Only mishap was that there were four people who called in late to ask if they could bring their animals. This was accepted, but they never showed up.

On the Fish Trap ride, there were approximately 15 riders, with only one wanna be rodeo ride experience. (We won't name names, but she knows who it is.) It was a cool, but beautiful day and everyone had a good time.

CPR Clinic and Saw Clinic – Perry said he has not received interest this year in conducting a CPR clinic, so PBCH will not go further with that. But, there will be a Saw Clinic with details to follow. Perry is coordinating this with George Miller and Terry Sverdsten.

Trail Clearing with the Ski Club on the 4<sup>th</sup> of July Pass trail in May - Perry never did hear from the President of the Ski Club to coordinate a joint trail clearing event. Bea Christopherson said Geoff Harvey is the contact person for them and they were looking at clearing trails there on May 30<sup>th</sup>. Bea gave Geoff's phone number to Perry and he will get in touch with him to see if they are still interested in us assisting in clearing trails with them.

The Remount Ride is still a go and if you are interested, all the information is in our newsletter on the website. Trail Bosses are the Jerry & Diane Shriner and Steve & Teri Horton. If you are going you need to make sure you get your permit, either via the website or at the store as stated in the newsletter.

Marie Creek Trail Clearing is slated on the calendar for May 9<sup>th</sup>. There was some confusion as to when the Marie Creek Fun ride would be and Perry thought it was June 6<sup>th</sup>. April Linscott said she would be the trail boss for the Fun Ride and Gene Bruce is the trail boss for the Trail Clearing party. (Please note correction – The Trail Clearing slated for May 9<sup>th</sup> has been changed, due to snow, to Saturday, June 6<sup>th</sup>. This will be in conjunction with National Trails Day. The actual Marie Creek Fun Ride will be Saturday, June 20<sup>th</sup>.)

Robert Wuest advised that there is grant money available, we just need to apply for the fund with the Idaho Park & Rec. The deadline is January 1<sup>st</sup>, which is a ways off. If we have a project or something we need, we should pursue the funds.

Al Linscott won the door prize of halter and lead rope.

Debbie Samovar made a motion to adjourned, second by Terry Sverdsten.

# TRAIL BOSS CHECK LIST

## I. ALWAYS BE ENTHUSIASTIC ABOUT THE PROJECT!

## II. BEFORE THE PROJECT:

1. Contact the agency which will be involved with this project (i.e.: USFS, BLM, Fish & Game) to establish the where; what; and why of the project.
2. Communicate with the agency regarding materials, tools needed, number of workers etc. Make certain everyone understands what is to be accomplished.
3. Enlist other members interested in the project to assist you. These people can help cover specific responsibilities of the project - this can range from trail work to camp helpers. Coordinate the project with these people.
4. Provide the Newsletter Editor with all pertinent information on the project. Include: Dates - Times - Project Description - Meal Plans - Water Availability -Contact Person and Phone # for Questions and/or RSVP - Directions with Map
5. Pre-ride and/or visit the project site if needed.
6. Prepare what is needed for the project and make arrangements to get them to project:
 

A. Map and Compass	D. Phone Numbers for Emergencies
B. Phones or Radios	F. Tools - Be sure tools are in good repair
C. First Aid Kits for Humans and Equines	E. Camp Necessities like: Food, Water, Firewood, B-B-Q Grill etc.
7. Plan for as many possible things that could happen.

## III. PROJECT DAY

1. Place directional signs to camp location.
2. Sign up all workers on Volunteer Agreement provided by agency. This is extremely important for insurance purposes.

## IV. AFTER PROJECT

1. Check if equipment is cleaned and ready to go, then return to storage shed.
2. Do the paperwork: Fill out trail report & follow up with agency regarding compensation (if any).
3. Provide Newsletter Editor with project report, include photo if available.
4. Give a wrap-up report at next General Meeting.

over Memorial Day weekend for no less than some great riding with possibility of some repair work on the corrals. There are several issues to deal with when visiting the corrals:

There is room in the corrals for a good number of horses, but if you have portable electric fencing, or can high line your stock, that is also a possibility depending on how many participants we have, and we will need an **RSVP from you by Saturday May, 16<sup>th</sup>** (also the day of our next Chapter meeting at the Dalton City Hall).

The second issue concerns stock water and drinking water. Within about ½ mile of the corrals there is a creek where you can get water. I take a 50 gallon barrel (an old orange surplus pickle barrel) and retrieve water for my horses, but you could use buckets and drive down the road to get stock water. Bring enough drinking water for the stay.

The last issue concerns how to get there. I'll give you my best shot:

When you reach the bottom of Lewiston Hill and take the exit to Lewiston, you cross the Clearwater River and just as the road angles to the right take a left turn onto E. Main Street and head east till you arrive at the entrance to the Potlatch Mill. Take a right on Lapwai Rd and at a "Y" take the Lindsay Cr Rd several miles climbing up to Grelle Ave. Take a left and you will soon have a 90 degree right on to 28<sup>th</sup> St. You will come down a steep hill and join Tammany Cr Rd (stay straight ahead).

Within about a mile after joining Tammany Cr Rd, take a right on Waha Rd (also called Road 540) past Waha Lake and as the pavement ends, stay to the left and take Road 541 (also called the Zaza Rd) and wind up the hill to the top (4 miles or so). A road intersects on your left that says "Soldier Meadows", and later the "Eagle Cr Rd". **DO NOT TAKE EITHER of THOSE ROADS.** Stay right and continue on the Zaza Rd (Road 540). Stay on the main road all the way to Madden Corrals which will be on your right. I believe it's about 14 to 15 miles from Waha Lake to the corrals. **Sound confusing?** A suggestion would be to go to "MapQuest" on the internet and type in Lewiston. It will bring up a map so you can see what I described above. Sherri and I will be leaving at about noon on Friday the 22<sup>nd</sup> and would be glad to have anyone follow us down. When you RSVP let us know about that.

Sherri and I will furnish breakfast on Saturday morning, lunches are always on your own. You will need to have breakfast fixings for Sunday and Monday mornings. Saturday evening and Sunday evening, bring your meat dish and a potluck dish. The grill will be available for cooking at all meals.

The rides shouldn't be difficult, although one we plan to take, guided by a Twin Rivers Chapter member, I haven't taken, but I do know it stays on the main ridge between the Salmon and Snake Rivers.

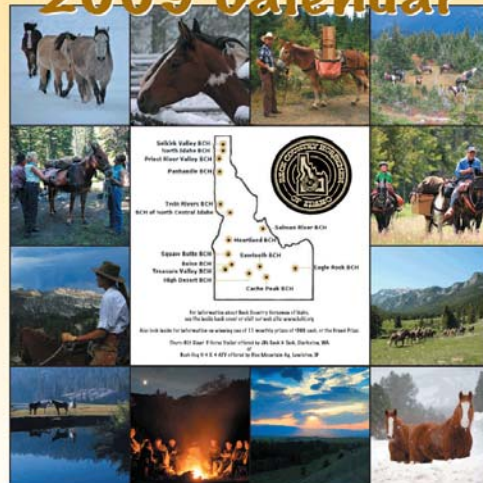

## Gentlemen on Horseback June 21 to the 26th

For over 50 years, men from all over the Northwest and beyond have gathered to participate in the "Gentlemen on Horseback" ride. There is a rich tradition that we can be part of. The ride was started when a group of Spokane-area horsemen decided to ride their horses from Spokane to the Okanogan Valley to participate in the Washington Cattlemen's annual convention. Nowadays, we drive our rigs to a designated camping area, set up a base camp and ride out every day for 5 days to different attractions in the area (lakes, mountain vistas, etc). The rides can range from 10 to 25 miles/day. The ride is catered so all meals are included in the fee of \$220/man.

This year the ride will be staged in and from the Oak Creek Wildlife Area near Naches, WA (west of Yakima in the foothills of the Cascades) on June 21 to the 26th. Besides the great food, this is an outstanding time of riding and sharing the company of other horsemen. While this is not a BCH-sponsored ride, in 2008 there were about 16 members (out of 37 riders) of several BCH chapters represented.

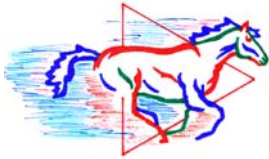

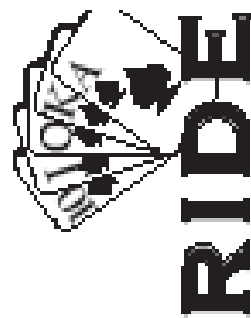
