THIS DOCUMENT IS A LEGALLY BINDING CONTRACT LIMITING YOUR RIGHTS TO RECOVER FOR INJURY AND LOSS!

Please read back of application and sign as indicated.

Nothing in this agreement is intended to limit the effect of or replace the limitation of liability provided by Idaho's Equine Activities Immunity Act, Idaho Code § 6-1801 et. seq. This agreement is intended to extend greater protection to the entities named below. By signing this document you waive your rights to bring any legal claim to recover compensation or obtain any other remedy for injury or death to yourself, your spouse, your children, or others for the loss or damage to property, however caused, arising out of the negligent or other tortuous acts of the officers or agents listed below, now or at any time in the future, caused by their actions or failure to act, or otherwise. You also agree to protect, defend, and indemnify the officers or agents listed below against all claims for injuries you cause to others in connections with any of their activities.

- **1. Definitions.** Herein "PBCH" means Panhandle Back Country Horsemen, its officers, agents, activity coordinators, activity leaders; "BCHI" means Back Country Horsemen of Idaho Foundation, its chapters, officers, directors and members. "I" means the undersigned individual, all heirs, and the members of their family, including any minors whether or not accompanying the individual, and the personal representative, executors, and administrators of the individual.
- 2. Release and Waiver of All Claims and Covenant Not to Sue. In consideration of participation in the activities of PBCH and BCHI by me, by my spouse, children and other dependents, I irrevocably waive and release PBCH and BCHI and the owners of all facilities, equipment, and land used in PBCH and BCHI activities from, and WAIVE MY SUBSTANTIAL RIGHT TO ASSERT ANY CAUSE OF ACTION, CLAIM OR DEMANDS OF ANY NATURE WHATSOEVER, including by not limited to, any claim of negligence, which I may have or acquire in the future against PBCH and BCHI on account of personal injury, property damage, death, or accident of any kind, arising from my involvement in PBCH and BCHI activities, however the injury or damage is caused, including, but not limited to, the negligence of PBCH or BCHI. I contractually release PBCH and BCHI and agree to hold PBCH and BCHI harmless from any and all liability for any claims, demands, damages, actions, causes of action, or suits of any kind or nature whatsoever, which result or may result in the future from activities sponsored by PBCH or BCHI or coordinated by PBCH or BCHI members. This release applies to all PBCH and BCHI activities in the future in which I may participate. This release shall be effective and apply to all my heirs and the members of my family, including any minors, whether or not accompanying me, and my personal representative, executors, and administrators.
- **3.** Legal Action Limitation. If any of the entities listed above has to take legal action in relation to this Agreement, and the entity is successful in the action, the unsuccessful party shall pay to the entity, in addition to all sums that the unsuccessful party may be called on to pay, a reasonable sum for the entity's attorney's fees and court costs. This Agreement shall be governed by and construed in accordance with the laws of the State of Idaho. Venue for any dispute or litigation arising out of this Agreement shall be in Kootenai County State District Court. Any modification of this Agreement or additional obligation assumed by either party in connection with this Agreement shall be binding only if in writing signed by each party or authorized representative of each party. There shall be no oral amendment or modification of this Agreement.
- **4. Acknowledgment of Risk.** I hereby acknowledge and agree that activities of PBCH and BCHI are frequently inherently dangerous and have a high degree of risk. I acknowledge that by execution hereof, I am waiving and releasing all claims against PBCH and BCHI for any injury whatsoever. I agree to participate as a common adventurer, being personally responsible for my own safety and not looking to any others to protect me from harm.
- **5. Statement of Capacity and Understanding.** I will not undertake any activity of PBCH or BCHI without becoming fully aware of the nature and extent of the risks inherent therein. By participation, I am voluntarily assuming the risks. I will not engage in the activities unless I am in good health and have no physical limitations, which could preclude my safe participation. I understand I am responsible for my own instruction in safety and providing for my own safety. I am of lawful age (18 years or older) and other wise legally competent to sign this agreement. I understand that the terms of this agreement are contractual and legally binding. By signing this agreement, I acknowledge that I have carefully read this agreement, and sign if of my own free will.

Draft Omnibus Lands Bill

From: Dennis Dailey ,Senior Advisor Wilderness, Recreation & Trails

The bill contains:

A proposal for a suitability study for Camp Hale in Colorado to determine if 200,000 Acres White River and San Isabel NFs should be designated as a National Park.

Proposed Wilderness:

Organ Mtn-Desert Peaks Wilderness (New Mexico):

Aden Lava Flow - 27,650 AC

Broad Canyon – 13,900 Ac

Cinder Cone - 16950 Ac

Organ Mtn - 19,400 Ac

Potrillo Mtn - 125.850 Ac

Robledo Mtn – 16,950 Ac

Sierra De Las Uvas – 11,100 Ac

Whitethorn - 9,600 Ac

Also includes National Conservation Areas (to conserve, protect and enhance for benefit and enjoyment)

Alpine Lakes Wilderness Addition (Washington)

Devils Staircase Wilderness (Oregon)

Rio Grande del Norte Conservation Area (Taos City New Mexico), also contains:

Cerro Del Yuta Wilderness 13,420 Ac

Rio San Antonio Wilderness 8,000 Ac


In addition it contains a couple of National Monuments, National Heritage Areas, and Wild and Scenic Rivers.

An interesting provision in the bill (Subtitle B – National Forest Insect and Disease Authorities) would "ensure that adequate emphasis is placed on the mitigation of hazards posed by landscape-scale epidemics of bark beetles and other insects and diseases" and "help focus resources within areas characterized by landscape-scale insect or disease epidemics ..." in the 13 western states (including Alaska). This might provide some help in mitigating the massive downfall on our National Forest trail system.

Rigging for Trail Work Manual

Hi folks, this is John Nelson in Mancos, Colorado. I'm contacting you to see if you or anyone you know might use stock for rigging work on trails, doing trail maintenance and construction, bridge work, etc. An FS friend of mine, David Michael, whom I know some of you know, too, is writing a manual on rigging for trail work for the Forest Service, and is looking for any information you may have on how you might do rigging work. The manual is being published by the FS's Missoula Technology Development Center (MTDC). David's written or collaborated on a number of FS manuals in the past, especially crosscut saw stuff and others, and I think this new rigging manual he's working on will sure be handy. Here's what David told me about this project:

"After being at MTDC for almost three years they finally did a rough edit on my Rigging for Trail Work Manual manuscript I've been writing for almost 10 years. Yup you guessed it now it's on the fast track. Question for you. With your connections with BHC, do you know anyone who has used draft animals for trail rigging work. This could be ground skidding of logs, using an animal to pull a line down the trail thus raising buckets of rock from the creek below or any number of other types of projects? I've done a little, or been around a little, but wanted to talk with a more knowledgeable person."

So my question to you folks is do you or anyone you know do rigging work? Myron, Biff, Dennis, Darrell, Colorado Trail. Southwest Conservation Corps folks, others, are you folks doing this, or do you know someone who does? If so, could you provide me any information you might have on it and I'll get it to David for possible inclusion in the manual? Could you pass this on to people you know who may have information? I'd sure appreciate it, because I think the manual might be even better as a result of your input. Although he's being humble about it, David's pretty darned good with rigging, as some of you know. I've seen him do some really neat stuff with a horse or mule while constructing trails or building bridges, but I also know that he knows you folks probably have some good information on the topic, too.

Anyway, if you are interested in this and have some information for David - or if you have other contacts for me for this, I'd appreciate hearing from you. Given the fast track for the project, can I hear from you within a few weeks - the sooner would be better, if possible.

Thanks in advance for any help you might provide with this. I hope everyone's well and enjoying the holidays. We've been getting hay in here, gathering and weaning cows, shipping, hunkering down for winter, etc. but I have to tell you that I'm already looking into April, thinking Spring's just around the corner, and that we'll be back on the trails!




