#### PANHANDLE BACK COUNTRY HORSEMEN FEBRUARY 19, 2011 MINUTES

President Bob Williams called the meeting to order at 7:03 PM

Bob said he plans to call members who do not renew to see why and what the club could do to improve things.

January minutes were read, corrected and are now part of the record.

T-SHIRTS and PATCHES - Bob Williams reported that Monogram Plus is moving from their 4th St. location to a shop at their home at 3112 S Progress Rd, in Veradale, WA 99037. They will keep the current phone #. They will charge a one time fee of \$61 for the set up and \$60/hour to convert our large embroidery logo to whatever format we select. Pocket patches are \$8 ea for 1-24 pieces and \$7 ea for 25+. Base price of T-shirts are \$6 ea. For embroidery add an additional \$5. For 3 color silk screening add \$2.75 for a quantity of 1-23, \$2.25 for 24-47 and \$1.95 for 48-70.

There is a bog at Lost Ck, we can't put in a bridge this year, but maybe puncheons. Al Linscott is going to check on the condition of the bog in April/May.

STATE BoD MEETING PROPOSAL - Bob Williams read a proposal from Squaw Butte regarding the fact that the newly created ID Parks & Rec state wide trails web site <a href="http://trails.idaho.gov/#">http://trails.idaho.gov/#</a> does not include horsemen in its detailed descriptions of non-motorized trails. The website is composed of information obtained from the Federal National Forest Service, BLM as well as Idaho state agencies and that the Federal agencies are mandated by law to include all user groups. So it has been proposed that the chairman of BCHI write a letter expressing such concerns to the Director and the Chairman of the Board of ID Parks & Rec. We are in agreement.

UPPER LOCHSA LAND EXCHANGE - Bob Williams reported that there's a great article in the *Bugle* Rocky Mountain Elk magazine. According to the article, this land would become FS property and would prevent patch work of public lands, keep out developers and keep land open to the public. Jerry Shriner commented that Western Pacific Timber Country, the developer, was formerly the Plum Creek Timber Co and all of this land has been logged and they want to trade it for treed land that can be split into 40 acre lots.

1099 FOR HORSE BUSINESSES - Bob Williams reported that there is an amendment to repel the new requirement of all horse businesses to send out and file 1099's for anyone they buy \$600 or more for supplies. Additionally, to show you how far CA has come north, WA now has a bill that has been introduced that we would have to supply shelter and bedding for all of our horses. Each horse would have to have so much space. This is part of trend of turning horses from livestock into companion animals.

Karen Kimball has received the Horse Self Defense DVD and asked if members could check it out, which we can. Also the same company produces a DVD on de-spooking your horses to autos, baby carriages, trucks, etc. We may want to pick this one up too.

The Spokane Tack Swap is on March 12th.

Joni Lueck request on behave of Bea Christopherson and the Nordic Club that PBCH write a letter of support for closing road 614 at 4th of July Pass during the winter. Perry Saathoff stated that it's not in the chapter's charter to do this, but we can as individuals.

# If they are important to you, let your Representative know now!

Every individual and organization concerned with trails and bike/ped facilities should tell their members of Congress why funding for these programs is important.

#### Federal budget cuts will affect trails

This week in Washington, the focus is on the federal budget, the deficit, and proposed cuts to spending on every aspect of national programs. The House of Representatives will vote on legislation (H.R. 1) that would cut current spending by at least \$100 billion below the President's FY 2011 request. Floor debate begins Tuesday.

#### Here's what we know so far that will affect trail funding:

**Land and Water Conservation Fund:** The House proposal would reduce funding for trails, parks, and land conservation by 90 percent. Funds that are appropriated to states would be virtually eliminated.

**Federal land management budgets**: Major cuts are also proposed in the current House budget for a wide variety of construction, maintenance, and supporting programs on federal public lands. This includes trails and recreation areas on National Forests, Bureau of Land Management lands, US Fish & Wildlife Refuges, and the National Parks.

ATTENTION: Devastating attack on trails, walking, and bicycling could happen this week! Though we do not know details yet, we anticipate a congressional amendment that could do away with or hobble transportation-funded programs like the Recreational Trails Program, Transportation Enhancements, (the nation's largest funding source for trails, walking, and bicycling), and Safe Routes to School. There is strength in numbers! Therefore, we are working with many other organizations to defeat such a damaging amendment. No action is needed to protect these three programs at the moment; we just wanted to give you a heads-up that an amendment could be offered in the coming days. You can expect an action alert from us. If it comes, please do not delay in speaking up. If such an amendment is offered, we might have mere hours to respond.

**Proposed House budget**: Read the details of the House proposed reductions in federal programs for the fiscal year ending Sept. 30, 2011: Table of FY 2011 Continuing Resolution reductions (pdf 53 kb)

**Hearings on Federal Transportation reauthorization**: The House Transportation Committee has scheduled a series of field hearings on Federal Transportation reauthorization during February 2011, starting with West Virginia on Feb. 14 and moving on to the West Coast by Feb. 21-23. Plan to attend these sessions and speak up for continuing trails and bike/ped facilities (Recreational Trails Program, Transportation Enhancements, and Safe Routes to School) in the next reauthorization bill. **Please help spread the word!** 

#### TAKE ACTION!

American Trails and other nationwide organizations have been urging key members of Congress and Administration officials to recognize the importance of funding for trails and related facilities.

There is strength in numbers and we need to present a unified voice for trails, to tell their story, to present their endless benefits, and to make the case for funding them. Join us in contacting your Senators and Representatives to let them know why these programs are vital to your local efforts.

# AHC WASHINGTON UPDATES

**FEBRUARY 3, 2011** 

### 1099 Reporting Requirement Amendments Passes

This week the Senate approved an amendment to the FAA Air Transportation Modernization and Safety Improvement Act that will repeal the recent 1099 paperwork mandate. The amendment was offered by Senator Debbie Stabenow (D-MI).

The 1099 paperwork mandate was a provision of the health care bill passed last year that imposes new tax reporting requirements, on every business in the U.S., including those in the horse industry, beginning in 2012.

There were several attempts to repeal the 1099 requirement last Congress which failed.

The AHC supports repeal of the new 1099 reporting requirement.

#### **Background**

The Patient Protection and Affordable Care Act ("Health Care Bill") that was signed into law last year included a provision broadly-expanding 1099 IRS form reporting requirements starting in 2012. Currently the law requires 1099s to be sent to any independent contractor that receives \$600 or more from a business in a year. The new requirement requires 1099s be sent not only to independent contractors but also to any individual or corporation from whom a business purchases a total of \$600 or more in goods or services in any given year. Its stated purpose is to identify unreported taxable income, fraudulent tax deductions, and increase tax compliance.

This new requirement will greatly increase the administrative burden on all businesses, particularly small businesses, including those in the horse industry. For example if a horse farm buys \$600 worth of hay and grain from a particular retailer, or purchases buckets and bridles for a total of \$600 from a tack shop, or an even buys office supplies of \$600 from a supply store over the course of the year, or an individual buys a computer for \$700 from a local store, they are required to issue each business a 1099 form that must be completed and returned to the IRS. This reporting mandate places an added burden on each business involved. The horse businesses would have to collect information and tax identification numbers for every entity they do \$600 worth of business with and mail them forms and the business receiving the forms must complete them.

The Stabenow amendment repeals only the new reporting requirements. Businesses would still have to send 1099s to independent contractors.

#### **Next steps**

The Senate must now approve the FAA Air Transportation Modernization and Safety Improvement Act which will then be considered by the House. Repeal of the 1099 provision has broad bipartisan support. But the larger bill may or may not pass both the Senate and the House. Therefore, repeal at this juncture is not assured.

Senator Mike Johanns (R-NE), Senator Max Baucus (D-MT), Congressman Dan Lungren (R-CA), and Congressmen Steve Scalise (R-LA), have each introduced stand alone bills that would also repeal the 1099 provision.

### House Transportation Committee Hearings on Next Highway Bill

Every several years Congress passes a multi-year national surface transportation bill. This bill funds transportation projects and programs such as the Recreational Trails Program (RTP) which provides money for state and local trail projects.

The House Committee on Transportation and Infrastructure has announced a series of field hearings that will take place in February on the next multi-year national surface transportation bill. The Committee will seek input on priorities for the bill.

#### Contact your Representative's and Voice your support for the Recreational Trails Program!

#### **Recreational Trails Program**

The RTP provides funding directly to the states for recreational trails and trail-related facilities for both non-motorized and motorized recreational trail uses. The RTP will have to be re-authorized in the next national surface transportation program bill if it is to continue.

Since its inception the RTP has provided approximately \$700 million for thousands of state and local trail projects across the country, including many that benefit equestrians. RTP projects consist of construction, maintenance and restoration of trails and trail related facilities as well as the acquisition of easements or property for trails.

Although each state manages its own program, 30% of RTP funds must be spent on non-motorized projects like equestrian trails, 30% on motorized, and 40% percent on multiuse projects.

The RTP is one of the few sources for federal funding of trail projects that are not on federal land. The program is a great resource for equestrians to fund projects in their state and local parks.

The AHC in conjunction with a broad coalition of recreational users has been working to ensure RTP is included in any national highway bill passed by Congress.

### **Draft Forest Service Planning Rule Released**

On February 14th, the Forest Service published a draft planning rule for public comment. The Forest Service planning rule will be used to guide individual forests in setting policies over the next 15 years. The Forest Service planning rule will impact users of the National Forests including equestrians.

#### **Background**

The last Forest Service planning rule dates from 1982 and focused primarily on resource management. The National Forest planning rule provides the overarching framework used by individual forests to develop land management plans. The planning rule will impact all aspects of the National Forests including recreation, wildlife and fish, wilderness, grazing rights, and timber, energy, and mineral production.

The recreational community, including the American Horse Council, had urged the Forest Service to make sure recreation was adequately addressed in the new planning rule to reflect the reality that it is a major use of our nation's National Forests.

"We believe this rule will provide for sustainable recreational opportunities recognizing the important role that outdoor recreation plays in the economy of rural America that surrounds these forests," said Secretary of the Department of Agriculture Tom Vilsack in his remarks introducing the draft rule.

There will now be a 90 day comment period that ends May 16, 2011. The Forest Service will review all submitted comments and then issue a final rule. The American Horse Council will be reviewing the proposed rule and its impact on equestrians and submit comments to the Forest Service.

# **BLM Funding Faces Potential Cut**

The Bureau of Land Management (BLM) would lose \$2 million in funding if an amendment introduced and sponsored by U.S. Representative Dan Burton (Ind.) earlier this week is approved. Burton presented the funding cut as an amendment to an omnibus spending bill, and House members approved the amendment by voice vote Feb. 16.

According to BLM estimates, more than 38,000 wild horses and burros reside on agency-managed rangelands in 10 Western states. Another 40,000 animals culled from ranges during scheduled roundups reside in short- and long-term holding facilities. During fiscal year 2010, the BLM had a budget of \$63.9 million. Of that, \$36.9 million was used to maintain animal holding facilities. The Obama administration has requested the BLM receive \$75.5 million in funding in fiscal 2011.

In presenting the amendment, Burton characterized the agency's gather and holding policies as inhumane, costly, and ineffective at managing wild herds. He said the funding reduction set forth in the amendment represents a protest against those policies.

"It is just a drop in the bucket when you are talking about this overall cost problem we're facing," Burton said. "But it is one that I hope will send a very strong message to the Bureau of Land Management, to treat mustangs in a humane way and to solve this problem in a way that is acceptable to the Congress of the United States and the people of this country."

BLM Spokesman Tom Gorey said the agency had no comment on the amendment.

Equine welfare advocate Jerry Finch, president of Habitat for Horses, a Texas-based equine rescue organization, applauded Burton's initiative.

"I'm glad Dan Burton has the courage to point out another failed policy and the absolute waste of taxpayer's money," said Finch. "There is far more to this than will ever meet the public's eye."

Meanwhile, Karen Sussman, president of the International Society for the Protection of Mustangs and Burros, hopes the funding loss will encourage the BLM to rethink its gather policies.

"I am hopeful that this will slow the BLM down in removals," Sussman said.

But Sarah Ralston, VMD, PhD, Dipl. ACVN, who observed gathers in California and Utah this past summer, does not believe limiting gathers is best for wild horses. Failing to remove animals from ranges affected by weather, drought, and competition for resources put horses at risk, she said.

As a result, Ralston believes reducing BLM funding could ultimately harm wild horse herds, especially if gathers are reduced as a result.

"Cutting the BLM funding will create crises in the wild horse populations, which will ultimately result in their demise, period," Ralston said. "The blockage of roundups this summer resulted in many deaths at Owyhee, Nev. Gathers were blocked until it was too late to save the horses in the drought conditions, and many died on the range. The ones that died in the gathers were due to the fact they were already debilitated."

The spending bill containing the Burton amendment remains under House consideration. If the House passes it, the entire bill will move on to the Senate for consideration.

# **Nebraska Horse Processing Bill Advances**

A measure intended to facilitate private sector horse processing plant development in Nebraska was approved by that state Senate's Agriculture Committee on Feb. 15.

The bill, <u>LB 305</u>, would establish a state inspection program for plants that process meat and poultry for human consumption. The program would operate under USDA State Meat and Poultry Inspection (MPI) Program requirements.

MPI programs operate in several states under a cooperative agreement with the USDA's Food Safety and Inspection Service (FSIS). Under the agreement, participating states must enforce food safety requirements that meet or exceed those contained in the Federal Meat Inspection Act and the Poultry Products Inspection Act. Food products produced under the state inspections may not be distributed across state lines. Meat could be exported if plant operator can develop business ties with foreign markets, or if a foreign company is the developer.

The bill's sponsor State Sen. Tyson Larson said the measure would support existing plants that process grass-fed cattle, bison, elk, and ostrich. The measure would also invite horse processing plant developers to the state, he said.

The bill now moves on to the full Senate for consideration, said a spokesman for committee Chairman Tom Carlson.

Valerie Hinderlider, operator of the Break Heart Ranch horse rescue in Minden, Neb., opposes slaughter plant development in Nebraska.

"It would set a horrible precedent," Hinderlider said.

Elsewhere, HB 1072, a South Dakota measure that would have authorized a state-funded horse processing plant development feasibility study has died in that state's House of Representatives Appropriations Committee.
