#### Get out of the Saddle

When it comes to keeping trails open, the words "traditional" and "historical" are usually found or read somewhere in the presentation or written material. But in addition to "traditional" and "historical", the word "responsibility" should be added to those adjectives!!

There are a lot of us trail riders and horse campers who "THEY" will keep open. "THEY" will make sure our horses have a hoof hold. "THEY" will keep the camps available to our uses. The problem with that logic is that "THEY" includes everyone–me, you,

Each year there is more and more demand for uses on public trails. There used to be a time that the "traditional" and "historical" users of trails were hikers and equestrians. Then came the bikers. Backpack-ers. And now it's roller boards (with huge wheels for going over rocks) and other users. Plus new ruling is requiring the opening public trails to "motorized wheeled uses that meet ADA uses". The words of "historical" and "traditional" will someday in the future include just about anything one can think of on trails!

"Responsibility" for keeping trails and camps open falls to equestrian trail users. Like every aspect of the equine industry, certain folks enjoy certain type of activities on the backs of their horses. Roping. Rodeo. Jumping. Dressage. Gymkhana. Shooting with the largest percentage of horses used for recreational trail riding. Which brings into play "they" heard around and-in meetings is in reality "us" — the recreational trail riders.

Spring is here and trails are soon going to be reopened. Winter always has a toll on trail conditions and after winter, some trails are closed because of "budget shortages" which is where a local group of "us" should step up and say "We'll work on that section of trail" or "You provide the material, we'll provide the muscle to drive nails and replace that bridge". In other words, get out of saddle for just one or two days to help clear, clean, repair a section of trail or a structure in a horse camp.

If one can't couple days or even one day or few hours a month the entire spring, two hours at a trail head to repair a fence, fix a gate, drive some nails in where some fell out— anything will help keep that area open.

I've seen trail heads closed off complete on the part of the equine trail users. In one case, a gate had fallen off a broken hinge. Gate wouldn't open "from the saddle". Some trail riders complained about it to the ranger. The ranger had no time because of "budget cuts". And to keep the "public safe" the trail head was closed to equestrian users for 4 years!! In reality, if the trail users had taken a couple hours out of one day's riding and FIXED the gate themselves, the trail head would have been open for those 4 years.

Keeping trails and camps open does have a "tradition" and a "historic" value, but "responsibility" is just as important in these days of budget cuts and more demands from more people to use trails. So to help keep our trails open, we've all got to get out of the saddle and grab a little "responsibility" by working on a trail, in a camp even if it means 3 hours of lost riding time. Riding through a gate that's still open because YOU fixed a hinge or kept the water flowing at a horse camp because YOU retighten a valve or YOU repaired a section of corral fence in a horse camp sure gives YOU a warm and fuzzy feeling just knowing YOU did it!!



#### The Remount Ride May 7-8, 2011



Diane & I will be there Fri before noon. People are welcome to come whenever. We will fix breakfast for everyone Sat and Sun mornings and just charge for the actual cost which has been about \$5 per breakfast in the past. Lunch is on your own and supper is the usual potluck and bring your own entree. Kids are encouraged and dogs allowed except in the kitchen and dining room.

Directions: Take I-90 to the St Regis exit. You will be on Hwy 135 headed down the Clark-Fork River toward Hwy 200. Continue about 22 miles to the junction of 135 and 200. Turn right/east and go about 10 miles to Perma. Don't blink. It is only about two buildings. Turn North on Hwy 382 across the bridge over the Flathead River and immediately turn east onto the gravel road headed up river. Go about two miles to the remount station-a bunch of old buildings and corrals. You can't miss it. These directions work best for most Idaho residents.

You must have a tribal conservation permit and camping stamp for each person 18 yrs and older. You can buy them at Plains, but it is easy to get them on line and you have plenty of time if you start now. Tribal officials will be checking so don't think you can slip through. Plains is a few miles west on Hwy 200 so if you want to buy that way turn west at the 135/200 junction to Plains and stop at the first place you come to. To get the permit on line go to <a href="https://app.mt.gov/Als/Index">https://app.mt.gov/Als/Index</a> click the item that pertains to you. This will take you to the ALS number page. If you have had any kind of license or permit from the Mt F & G you will have an ALS

number and you can search for it from this page. If not, just follow the directions and get one. Click submit and you should be at <a href="https://app.mt.gov/Als/">https://app.mt.gov/Als/</a>. Scroll down to the CSKT Tribal license section and choose either the 1 year for \$15.00 or the out of state 3 day for \$8.00. The camping stamp can be purchased at the same time as the conservation permit. It is the first item in the CSKT section of the online licensing page. Proceed to the check out and you will get your permit in the mail. Print your receipt in case there is a problem.

Note: If you have already bought your conservation permit you only need to go back and buy the camping stamp in the same manner. MT F&G will send you a new form showing you have both the permit and the stamp. It really isn't a stamp, it's just another text line that says Flathead camping stamp.

**Skilled Labor** – Hours of activities requiring skilled labor such as packing, carpentry, bridge construction, use of power equipment saws, chain saws, etc. \$25.00/hr.

**Trail Recon Work** – Not requiring skilled labor. \$15.00/hr.

**LNT /Education** – Actual hours spent in preparation and conducting educations clinics, seminars, classes, and LNT Training. (This entry assists the agencies in meeting their requirements for educational activities.) \$15.00/hr.

**Public Meetings** – Actual hours spent in attending or presenting at public meetings relating to BCH activities or issues. \$15.00/hr.

**Administrative Work** – Includes the scheduling, coordinating and planning work rides within the chapter as well as coordinating rides with agencies and/or agency representative. The value is calculated as follows: 3% of the total hours at \$15.00/hr

**Trail Miles** –This is a new category for 2009 reporting. Actual trail miles worked on over the season are reported here. There is no dollar value assigned to this work. This new category will give a better picture of how many trail miles we actually work on/improve/maintain each season.

**Travel Time** – Actual hours going from home to projects, work rides, educational or public meetings and back. \$15.00/hr.

**Personal Vehicle Mileage** – Actual personal vehicle miles traveled from home to projects, rides and back. Use this if not hauling stock, otherwise use next column. \$.90/mile

**Stock Hauling Mileage** – Actual vehicle miles traveled with trailer and stock from home to projects, rides and back. \$1.10/mile.

**NOTE:** Often several people will travel together using one trailer for several animals. In this case, one person (the driver) is credited with stock hauling mileage. The passengers are credited only with travel time.

**Power Equipment Hours** – Total hours for power equipment used on projects, i.e., chain saws, power pruners, etc. Use local rate or if unknown can use BCH rates.

**Heavy Equipment Hours** – For use of heavy equipment used on projects, i.e., backhoe, tractor, post drivers, etc. Use local rate or if unknown use BCH rates. In calculating the rate of power equipment or heavy equipment an additional \$3.00/hour should be added to the rate calculation.

**Donations, Dollars or Materials Value** – Donations of money, material supplies (nails, gravel, etc.) from chapter coffers, personal accounts or business accounts.

Quantity Stock (Pack and Saddle) - Number of animals used to complete a project.

**Number of Stock Days** – Even if an animal is only use for part of a day, the time spent in travel and use should equal one day per animal. If 2 animals are used for one day that equals 2 stock days. If 2 animals are used for 2 days that equals 4 stock days. Valued at \$100.00/day






