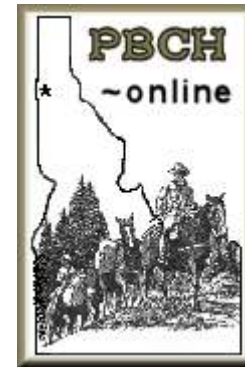

I hope you are all enjoying the early spring weather. If you haven't already been riding you soon will be so this might be a good time to reconsider how and why we ride.

First and foremost is safety. Accidents can happen to any of us but there are some simple preventative things we can do. For example take a few evenings to do some ground work with your horse. Remind them of those skills and behaviors they displayed last fall before you put them up for the winter and do it before you get on. While you are thinking about it consider getting a lesson or two now that will make the coming season even more enjoyable for you, your horse and your fellow riders.

Since accidents can and do happen, be prepared. Study up on wilderness first aid. Consider carrying a first aid kit whenever and where ever you ride. Buy LifeFlight insurance. It is only \$45 for PBCH members (we'll get the application on the PBCH website) and could save you a ton of money if you need a quick trip to the ER. Get a SPOT Locator or some similar device and service. It could save your life. No one can help you if they don't know you are in need and where you are.

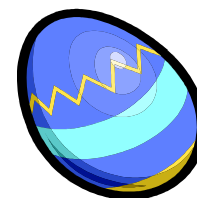
PRESIDENT'S REPORT

NEW BUSINESS

Consideration of resolutions- these were passed out and emailed last month and will be voted on at the state meeting in April. A five minute recess was called for review purposes. Diane discussed the calendar revenue resolution. Deborah shared her input opposing the resolution. An advisory hand vote was taken. No one voted in favor of the calendar revenue resolution.

Three other resolutions were discussed including a by-law change that would allow five or more chapters to call a meeting, in effect requiring the chair to comply.

Karen made a motion to allow up to \$100 for a silent auction item for the state convention. A second was made.

Karen made a motion to spend \$100 for a North Idaho Fair Open Horse Show program ad for PBCH. Deborah made a second.

USFS letter was signed by Karen for a \$1300 cost share agreement if we finish our service projects. Karen also mentioned that the USFS in Idaho is cutting back on their stock and not giving funds for hay at a time when the federal funds have increased by 3%. This will be brought up by our regional chairman.

There are different routes to the ranch. This is the best: from Idaho go west on I-90 to the Sprague exit 245, go south on State Hwy 23 8.1 miles to Lamont Rd, turn rt and go 2.6 mi to a Y and keep left on Revere Rd 8.3 miles, turn rt on to Jordan-Knott Rd 2.2 miles to the BLM Rock Cr Management Area sign, turn rt 2.5 miles to the trail head. There is stock water, pasture (but you may want to bring your own weed-free feed) and ample parking. There are no trees for highlines and only two small pens. The ride Sat. will be about 12 miles and Sun. to Towel Falls a little shorter. We will have coffee in the mornings and have the grill going for folks who want to gather around the fire and share breakfast. Plan on potluck Sat evening.

May 23-25 Memorial Day Weekend Ride and Campout. Bob Funke trail boss. 660-7919 Fordyce Trailhead up Asotin Creek out of Asotin, WA. It is a nice trailhead with fire pit and several trails out of parking lot. Horses will have to be tied to trailers or high-lined. Trails will climb to a ridge top, good trails and gradual climb, but horses should be in shape and shoes are recommended. We will be riding 4+ hours Saturday and Sunday. A Discover Pass (parking pass) will have to be purchased from Fish and Game in Washington for \$35, good for a year, or you can get a one-day pass for \$11. Purchased online or at the Jiffy Stop in Asotin. The store is one block south from Asotin Creek Rd., where you turn. The store is open 24 hrs.

Directions to trail head: After going down the Lewiston grade, drive through Lewiston City Center and cross bridge into Clarkston. On the bridge stay in left lane. After crossing bridge take diagonal street to Clarkston City Center and Asotin. At next stop light turn left following same signs. It will take you approximately 2 to 2 1/2 hrs from CDA to get to Clarkston.

April 4 Vet/Tune-Up Clinic

From Clarkston continue on same road Hwy 129 going , South through town and then along Snake River 5 miles to Asotin. As you come into Asotin, turn before bridge, first road in Asotin, on (Beaumaster Drive) Asotin Creek Rd #110. When you come to a "Y" Keep right and stay at creek level. Road will go back and forth from paved to gravel. After the third time it changes to paved and gravel go right at the next "Y" intersection. A few miles you will go past a couple barns on the right and a cattle guard. After the second barn, look for a sign along the left side of road (Fordyce Trail Head), hitch rail, and large grassy area with a parking lot. You are there. It is about 45 minutes from Asotin and road is always in good condition.
