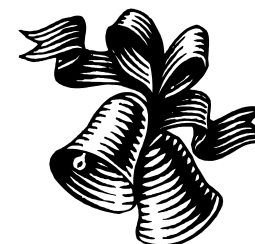
Arnie Wilkens, Board of Directors member, opened new business by informing the members that the BCHI is putting forth a vote at the state convention to raise local chapter's state dues.

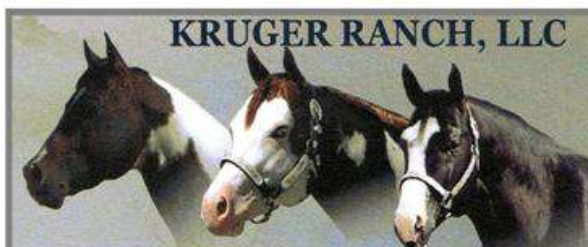

Dues are currently \$15.00 for individuals and \$18.00 for family members. The state BCHI is seeking a \$5.00 increase.

Debbie Samovar said that the State needed the raise for increased expenses i.e. national travel back and forth to Washington D.C. for issues facing our organization . Debbie was very helpful in answering questions and explaining the increase. Mike Anderson made a motion to have a show of hands in favor of the increase, a vote which is not necessary at this time. A majority was in favor.

BCHA wants to place a full-sized ad in USA Today newspaper. The ad would coincide with a feature article on National Parks. The ad will cost approximately \$10,000 and be shared by all 27 states. The ad will be designed with the help of Robbin Schindele, state media director.

Mileage Reimbursement PBCH BOD suggested that a one-way, \$.50 per mile reimbursement for members participating in work projects. Motion made by Bob Funke , seconded by Jill Reineccius. Passed unanimously. A member will complete a form about the work project location and mileage and turn in to PBCH Treasurer Stan Smith or the project trail boss.

State Convention fee reimbursement Karen asked for 2 more delegates for Convention next month, Jill Reineccius volunteered. At the same time Arnie Wilkens brought up the fact that only half the registration fee for Convention is paid for by PBCH. He felt it should be the full amount of the registration fee which is \$60.00. A motion was made to raise the payment to the \$60 registration fee by Bea Christopherson and seconded by Debbie Samovar. Approved.

2016 trail rides and work details were read by Arnie just to let the members know there are lots of events are happening this year. Not all rides are confirmed but the members were told to read the newsletter and web site calendar for confirmation of dates and locations. Dual rides were explained whereby a local day ride was scheduled the same date that an out of town weekend ride was schedule, thus allowing members a choice.

Meeting Day Change Debbie Samovar made a motion to change our meeting day to be a single Wednesday all year long. Carla Van Lauding seconded, passed. Effective May 18th. The March and April meetings will be the third Saturday until the change in May.
