# Memorial Weekend ride and campout. See Calendar. Featured event for the upcoming riding season

Asotin, WA Campout and Ride This is the Fordyce Trailhead up Asotin Creek out of Asotin, WA. It is a nice trailhead with fire pit and several trails out of parking lot. Horses will have to be tied to trailers or highlined. Trails will climb to a ridge top, good trails and gradual climb, but horses should be in shape and shoes are recommended. We will be riding 4+hours on Saturday and Sunday. A Discover Pass (Washington parking pass) will have to be purchased from Fish and Game for \$35, good for a year, or you can get a one-day pass for \$11, purchased online or at the Jiffy Stop in Asotin. The store is one block south from Asotin Creek Rd. where you turn. The store is open 24 hrs. Directions to trailhead: After going down the Lewiston grade, drive through Lewiston City Center and cross bridge into Clarkston. On the bridge stay in left lane. After crossing bridge take the diagonal street to Clarkston City Center and Asotin. At next stop light turn left following same signs. It will take you approximately 2 to 2 ½ hrs from CDA to get to Clarkston. From Clarkston continue on same road, Hwy 129, going south through town and then along Snake River Rd 5 miles to Asotin. As you come into Asotin, turn before bridge, first road in Asotin, on (Beaumaster Drive) Asotin Creek Rd #110. When you come to a "Y" keep right and stay at creek level. Road will go back and forth from paved to gravel. After the third time it changes to paved and gravel go right at the next "Y" intersection. A few miles you will go past a couple barns on right and cattle guard. After the second barn, look for a sign along the left side of road (Fordyce Trail Head), hitch rail and large grassy area with a parking lot. You are there. It is 45 minutes from Asotin and road is always in good condition. We will potluck meals Saturday and Sunday and bring a meat to grill. We will have the chapter BBQ for your meat and will have camp stoves out to do your breakfast if you wish. If anyone can haul firewood let me know. Thanks, Karen Kimball

#### Convention Report 2019

- 1.BCH or Oregon and Washington's Resolution Concerning the Use of MRA's in Wilderness "Minimum Requirements Act" that within 2 yrs of catastrophic events, the agency will determinate what constitutes the appropriate tools and work on trails after:
  - A. A wildland fire has closed portions of a wilderness trail.
  - B. A wind event has closed portions of a wilderness trail
  - C. Any natural event has occurred and closed portions of a wilderness trail

BCHI voted yes to support Oregon and Washington in taking this resolution to BCHA.

- 2. Number of voting directors for BCHA to one for each state instead of 2. BCHI voted no
- 3.Resolution "To protect the principal and spend Gains/Interest from the BCHA Legacy Fund They will be asked for a vote of delegates at the BCHA convention. The Executive Committee approved this and they don't have the authority to do so.
- 4. Resolution for Calendar Rebate BCHI took this away so they could hold at least a 3-year capital reserve. This has been met so the State is going to give the 10% rebate back for calendars purchased. This went into effect for last years sales.
- 5. Chainsaw Certification Program We are going to continue with the same program where we have members of BCH do a training so they can certify members of chapters. The FS will still do the certification cards. Arnie Welkins and Jerry Shriner have to agreed to take this training.

New officers voted in were Rod Parks Chairman, Twin Rivers, Chris Reed Vice Chair, Moscow, Debbie Samovar will continue as Sec, Kay Ryan will continue as Treas., Aline Brinkmann will be second National Director From Eagle Rock
