#### Agenda

1. Trail Rides:

Antoine Peak- 13 riders attended. 2 Groups. 2 hour ride and 3.5 hour ride. BBQ hamburgers and potluck back at the trailers. Thank you Joni Lueck for organizing and bringing burgers. Irv and Susan Walker trail bossed longer loop; Joni Lueck on the shorter loop.

- 2. Questionnaire regarding what educational topics members would like to cover. Waiting for results of Questionnaire. Audra suggested contacting county weed abatement specialist. Diane suggested an expert to match horses with riders.
- 3. Dalton Community Picnic-Thank you to members of the Chapter that helped with this annual event. We had at least 10 members volunteer.
- 4. Honey Badger Project and Kootenai Fuel Project- Local public meetings were held with many displays of the Honey Badger Project. Project will cover 42000 acre area from Coeur d' Alene past Chilco Mt area. Forest Service is working to clear dangerous fire areas and to improve the health of the National Forest Lands. Any area that disturbs existing trails must be repaired. and money from lumber sales could possibly be put into recreational trails. The Fernan Grade is a possible area that may gain recreational trails.

There is a map and click on tabs on the website for more information. Kootenai Fuel Project is a Forest Service project thinning trees in the National Forest that boarders private land to reduce fire danger. Kootenai Fuel project also has a website with more information.

- 5. Lite House grant for 4th of July Recreation Area trailhead. PCBH is working with Panhandle Nordic group to bypass a trail near the trailhead that is in bad condition. Need to put up gate to prevent vehicle and ATV use. Hope to use Lite House grant money and possibly have a donation from a local welding shop to make gate and hopefully get some supplies donated by Pacific Steel.
- 6. Christmas Party: Still trying to secure good location for the party. Some suggestions from the floor that Karen is going to follow up on.
- 7. Calendars: 2020 Calendars are available to sell. Susan Walker to head Committee.
- 8. Election in November: Looking for Nominations for President, Vice President and Secretary for 1 year terms. We also have 3 positions for Board of Directors open.

Progressive Pot is now \$29: Name drawn was Kay Hansen who was not at the meeting. Pot rolls over to the next meeting.

#### Photo criteria

Must be of BCHI members, take by a BCHI member or taken for BCHI (such as a newspaper).

Can be taken in any state and the cover photo will be selected from Idaho submissions.

Must have a horse/mule in the shot.

Or be a work project with members wearing safety gear:

(hard hat, safety glasses/goggles, ear protection, gloves, chainsaw chaps).

Heads and faces preferred over tails and backs.

Kids photos welcome: If using saws they must have safety gear on.

Do not resubmit photos that have been used in previous calendars.

Photos are placed by seasons - winter, spring, summer and fall.

Winter photos: can have non-equine shots that show the effects of cold and snow.

Please submit as many photos as you wish on CD, DVD or USB drive. NO PRINTS. USB drives will be mailed back to you . If you want your CD/DVD back please let me know.

Photos need to be in JPEG Format. Set your digital cameras to the highest size settings possible.

Please do not resubmit photos that have been used in previous calendars.

If you only have a few photos or no way to burn them to CD or a USB drive, you can e - mail them directly to me. USB drives will be returned after calendar is printed.
