Agenda

- **PBCH Equipment Report** Karen Kimball reported that the old club trailer was advertised as a giveaway and was picked up by an interested party. The hitch and extender were sold for \$100. The replacement trailer for the club has been stocked and outfitted for use.
- Trail Clearing Karen Kimball announced that English Point trail had been reported as having a large tree down. Jim and Karen Kimball cleared the log to open the trail. Also reported as needing additional clearing due to recent downfall is the Marie Creek upper trail.
- **TWG Meeting** Karen Kimball attended the recent TWG meeting. Remarks were noted regarding the Honey Badger project. There was discussion of trail usage and it was stated that the most used trails will be kept open and can be utilized by mountain bike and motorcycle riders. Bud Howard trail around the pond is currently gated but it is hoped to be open after hunting season.
 - E Bikes Karen Kimball urged all club members to review the article in the recent BCH Nat'l newsletter regarding E Bikes and trail usage. The Secretary of the Interior has stated the E- bikes could be used on non-motorized trails, although the Secretary of the Interior does not oversee government lands. The National Forest Service states that the Travel Management Rule considers E bikes as motorized vehicles that may only be used on National forest Service roads and trails for motorized traffic. Members should stay alert and follow this topic as it could affect trails used by horsemen and their stock.
 - **SBD Meeting** There is now money to train our people for Chain saw/trail clearing skills. There are folks in Montana who can assist in First Aid/CPR Course as well as Ski Patrol and Life Flight. Our chapter is due for re-training in two years.

Volunteer hours are due December 1; Broomtales newsletter is looking for articles from each chapter; March 2020 BCHI convention will be held in Boise, ID.

- Fund Raiser Jamie Smith was not present at the meeting to provide an update. Topic to be pushed to the next chapter meeting.
- Calendar Sales: 2020 calendars are available for pick up by members for selling. Our club is responsible for selling 150 calendars.

Spring Ride Idea Escure Ranch

This location is southwest of Sprague, WA and has a beauty of its own. Very different than the beautiful wooded trails we can normally ride.

Today the Escure Ranch, which is 20,000 acres, is owned by the Bureau of Land Management (BLM) and offers spectacular scenery resulting from the Great Missoula Flood as it carved its way through the scab rock during the ice age to create deep hidden basalt channels. Many rock formations, cliffs and scenery in this area. It is a great place to have a large group ride.

There is plenty of room to spread out during the ride, park rigs, etc. Water trough at trail head. Creek crossings, and bridge, depending on where you ride. There is also a large water fall east of the ranch. There is cattle on the property, so be sure to leave gates as you find them.... close any gates that you open. Practice the normal "Leave No Trace" rules.
