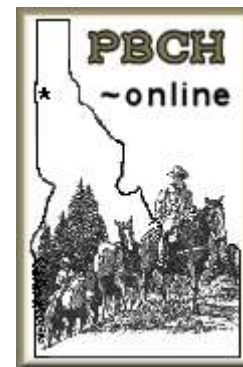

President's Letter

The chapter had 125 calendars to sell last year (2022) and we had some left over (not sure how many). We sent the cards in with PBCH written on them and we won the \$500 again. The drawing was at the end of September.

We do get 10% back from BCHI of the 125 calendars no matter how many we sell. We pay for the 125 calendars up front. The calendar money goes to BCHI and most of it is put into the Legal Fund. The State BCHI is trying to build this fund up to at least \$75,000. There is around \$30,000 in it now. This will be kept in case we have to go to court to keep public trails open and other issues with BCHI. The sales of 2023 calendars have been brisk. Get yours today!

Also our chapter received the \$1400 from the Forest Service for clearing trails.
